

General Requirements

Introduction

Winners will be selected by judging entries as described below. All applicable federal, state, provincial, municipal, territorial and local laws and regulations apply.

How to Submit

1. Author a unique bundle that is security themed.
2. Fill out the form on our web landing page, providing legal name, address, phone number, ExtraHop.com user name, email address, and the name of your bundle.
3. Submit bundle to the bundles gallery. You may submit multiple bundles for the Fall Bundles Contest.

How Bundles are Judged

We will announce the contest on September 22nd, 2016 and will be accepting applications from September 22nd to October 13th. There is one contest round. Judging will be done from October 14th to the 21st. A group of ExtraHop engineers will be judging the bundles based on creativity and the power of the bundle to promote the extensibility of the ExtraHop platform. If there is a tie, multiple winners will be announced.

What are the Prizes

One winner will be chosen. Winners will be notified by email with instructions on how to claim the prize. If a potential winner does not respond and comply with the instructions in the direct message within three (3) days after Sponsor sent the direct message, the winner will forfeit the prize and Sponsor may award the prize to an alternate entrant. Only three (3) alternate entrants will be contacted.
